



EXECUTIVE ORDER NO. 2016-001

REAPPOINTING THE MEMBERS OF THE BIDS AND AWARDS COMMITTEE OF THE CITY OF URDANETA

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, mandates all government entities, including local government units, to organize their respective Bids and Awards Committees that will oversee the procurement of Infrastructure Projects, Goods and Consulting Services;

WHEREAS, in compliance with the provisions of the law, the City of Urdaneta had organized its Bids and Awards Committee with the appointed BAC Officers, Secretariat, and Observers serving a term of one (1) year;

WHEREAS, given the one (1)-year term of the appointed BAC officers and other members is expiring, there is a need to reappoint them to another one (1)-year term to enable them to continue to pursue their mandates and to discharge their duties as provided for by law;

NOW, THEREFORE, I, AMADEO GREGORIO E. PEREZ IV, City Mayor of the City of Urdaneta, by virtue of the powers vested in me by law, do hereby reappoint the following as members of the City of Urdaneta's Bids and Awards Committee effective today, 4 January 2016:

Section 2. *Functions and Responsibilities.* The BAC, its Secretariat, and the Observers shall have the same functions and responsibilities as provided for by law and as enunciated in Executive Order No. 2004-001.

Section 3. *Effectivity.* This Order shall take effect immediately and shall remain in force for a period of one (1) year reckoned from the date of this Executive Order and unless earlier revoked.
