**RESOLUTION AUTHORIZING THE CITY VICE-MAYOR, HON. JULIO F. PARAYNO III, AND THE CITY TREASURER, MS. SANIATA A. ELEGORES, TO SIGN ALL CHECKS, WARRANTIES, DRAFTS, AND ISSUANCES CHARGEABLE AND ACCRUING TO THE FUNDS OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, AND TO TRANSACT BUSINESS WITH THE LAND BANK OF THE PHILIPPINES UNDER THE CITY’S GENERAL FUND ACCT. NO. 0112-101357, PURSUANT TO THE PROVISIONS OF REPUBLIC ACT 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, the passage and implementation of Republic Act 7160, otherwise known as the Local Government Code of 1991, guaranteed the separation of powers between the Executive and the Legislative branches in Local Government Units like the City of Urdaneta;

**WHEREAS**, attached to the powers given to the City Vice-Mayor, aside from being the Presiding Officer of the Sangguniang Panlungsod, is to appoint all officials and employees in the office;

**WHEREAS**, this carries with it the authority to sign all checks, warranties, drafts, and issuances chargeable and accruing to the funds allotted to the Sangguniang Panlungsod, and to transact business with the Land Bank of the Philippines, the depository bank of the Local Government Unit of Urdaneta;

**WHEREAS**, in view of the leadership change brought about by the just-concluded elections, the City Vice-Mayor, Hon. Julio F. Parayno III, shall now be the official signatory of the City’s General Fund Acct. No. 0112-101357 at the Land Bank of the Philippines, along with the City Treasurer, Ms. Saniata A. Elegores;

**WHEREFORE**, in view of the foregoing, on motion of Coun. Michael Brian M. Perez, duly seconded unanimously, it was:

**RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Urdaneta, in session assembled, to authorize the City Vice-Mayor, Hon. Julio F. Parayno III, and the City Treasurer, Ms. Saniata A. Elegores, to sign all checks, warranties, drafts, and issuances chargeable and accruing to the funds of the Sangguniang Panlungsod of Urdaneta, and to transact business with the Land Bank of the Philippines under the City’s General Fund Acct. No. 0112-101357, pursuant to the provisions of Republic Act 7160, otherwise known as the Local Government Code of 1991.

**RESOLVED FURTHER**, to cause copies of this resolution to be furnished to City Mayor Amadeo Gregorio E. Perez IV, City Vice-Mayor Julio F. Parayno III, all the Sangguniang Panlungsod Members, and City Treasurer Saniata A. Elegores for their information and guidance.
