AUTHORIZING URDANETA MAYOR AMADEO GREGORIO E. PEREZ IV TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA), REPRESENTED BY PROVINCIAL MANAGER RAMON B. CUARESMA, FOR THE PURCHASE OF RICE ON CREDIT FOR THE CITY'S RELIEF OPERATIONS IN TIMES OF CALAMITY

WHEREAS, National Food Authority (NFA) is the government agency charged with, among others, ensuring the nation's adequate supply and distribution of grains;

WHEREAS, under the Local Government Code (LGC), local government units (LGUs) are vested with authority to discharge the functions and responsibilities of national agencies and offices devolved to them;

WHEREAS, provinces/cities/municipalities in particular have been tasked with providing basic social services including relief assistance in times of calamities;

WHEREAS, LGUs are authorized to set aside an amount equivalent to twenty percent (20%) of their regular income/general fund for contractual debt servicing pursuant to the LGC;

WHEREAS, in order to provide immediate assistance to their constituents, the LGU has requested NFA to allow the purchase of rice on credit for relief operations whenever a state of calamity is declared either by the local legislative bodies or the Office of the President;

WHEREFORE, in view of the foregoing, on motion of Coun. Maria Teresa Socorro Perez-Naguiat, duly seconded unanimously, it was:

RESOLVED, by the 7th Sangguniang Panlungsod of Urdaneta, in session assembled, to authorize Urdaneta Mayor Amadeo Gregorio E. Perez IV to enter into a Memorandum of Agreement (MOA) with the National Food Authority (NFA), represented by Provincial Manager Ramon B. Cuaresma, for the purchase of rice on credit for the City's relief operations in times of calamity.

RESOLVED FURTHER, to cause copies of this resolution to be furnished to City Mayor Amadeo Gregorio E. Perez IV for his proper information and appropriate action.
