COMMENDING THE URDANETA CITY POLICE STATION UNDER THE LEADERSHIP OF PSUPT. JEFF E. FANGED, CHIEF OF POLICE, FOR A HIGHLY SUCCESSFUL “OPLAN TOKHANG” IN THE CITY

WHEREAS, the Urdaneta City Police Station under PSupt. Jeff E. Fanged, Chief of Police, has started implementing the national law enforcement initiative known as “Oplan TokHang,” short for “toktok-hangyo,” which in the Visayan vernacular means “to approach and talk”;

WHEREAS, “Oplan TokHang” is part of “Oplan Double Barrel” aimed at drug pushers and users of illegal drugs alike to put an end to their illicit activities;

WHEREAS, “Oplan TokHang” seeks to communicate the law enforcement initiative to the communities and not yet to aim at apprehension;

WHEREAS, thus far, the initiative has netted about a thousand user-pusher-surrenderees from almost every nook and cranny of the City in line with the police crackdown on illegal drugs;

WHEREFORE, in view of the foregoing, on motion of Coun. Herodotus F. Sumera, duly seconded unanimously by all present, it was:

RESOLVED, by the 7th Sangguniang Panlungsod of Urdaneta, in session assembled, to commend the Urdaneta City Police Station under the leadership of PSupt. Jeff E. Fanged, Chief of Police, for a highly successful “Oplan Tokhang” in the City.
