**AUTHORIZING MARKET SUPERVISOR CESAR T. ESTOESTA, IN COORDINATION WITH PUBLIC ORDER AND SAFETY OFFICE (POSO) CHIEF HENRY R. KANG, TO CLEAR PEREZ SOUTH STREET IN POBLACION OF ANY UNAUTHORIZED ENCROACHMENTS AND OBSTRUCTIONS IN VIEW OF THE PROPOSED ONE-WAY TRAFFIC SCHEME IN THE CITY**

**WHEREAS**, this August Body invited Market Supervisor Cesar T. Estoesta to a dialogue to explore ways to clear Perez South Street of encroaching stalls and illegally-parked trucks or vehicles, which block the main street and sidewalk and make life difficult for the riding and walking public;

**WHEREAS**, Mr. Estoesta promised this August Body that he will sit down with Public Order and Safety Office (POSO) Chief Henry R. Kang to discuss the matter and act on it with dispatch for the greater good of the people of Urdaneta;

**WHEREAS**, Mr. Estoesta will be armed by this August Body with the necessary resolution to authorize him to clear the area of unauthorized encroachments and obstructions in view of the proposed one-way traffic scheme;

**WHEREFORE**, in view of the foregoing, on motion of Coun. Jimmy D. Parayno, duly seconded by Coun. Blesildo F. Sumera and Coun. Herodotus F. Sumera, it was:

**RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Urdaneta, in session assembled, to authorize Market Supervisor Cesar T. Estoesta, in coordination with Public Order and Safety Office (POSO) Chief Henry R. Kang, to clear Perez South Street in Poblacion of unauthorized encroachments and obstructions in view of the proposed one-way traffic scheme in the City.
