**AUTHORIZING THE URDANETA CITY SCHOOLS DIVISION TO UTILIZE THE BARANGAY HALLS AND SIMILAR STRUCTURES OR SPACES, AND EVEN THE CITY LIBRARY, FOR ITS ALTERNATIVE LEARNING SYSTEM (ALS) CLASSES THAT CATER TO OUT-OF-SCHOOL YOUTHS AND ADULT DROPOUTS**

**WHEREAS**, it is the earnest desire of the Urdaneta City Schools Division, through the Alternative Learning System (ALS), to provide our out-of-school youths and adult dropouts with the necessary knowledge and skills to help them become productive citizens of the community;

**WHEREAS**, there is a felt need for a Community Learning Center in each barangay where the mobile teachers and learners can hold their classes as they usually meet under the trees or in houses for their instructional needs;

**WHEREAS**, to address this need, this August Body has offered the temporary use of barangay halls and similar structures or spaces, and even the City Library, as venues for better ALS teaching-learning interactions in Urdaneta;

**WHEREFORE**, in view of the foregoing, on motion of Coun. Maria Teresa Socorro Perez-Naguiat, duly seconded unanimously, it was:

**RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Urdaneta, in session assembled, to authorize the Urdaneta City Schools Division to utilize the barangay halls and similar structures or spaces, and even the City Library, for its Alternative Learning System (ALS) classes that cater to out-of-school youths and adult dropouts.
