RESOLUTION NO. 16

CALLING ON SECRETARY MARK VILLAR OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO CONTINUE THE SEVEN-KILOMETER (7KM) WESTERN URDANETA BYPASS ROAD ACCORDING TO ITS ORIGINAL PLAN AND DESIGN

WHEREAS, the Department of Public Works and Highways (DPWH) is currently constructing the Western Urdaneta Bypass Road, which is seven (7) kilometers in length and is parallel to the Manila-North Road at a distance of 1.7 kilometers apart;

WHEREAS, the previous Sangguniang Panlungsod passed and approved Resolution No. 321, s. 2016, dated March 7, 2016, “appealing to Honorable Secretary Rogelio L. Singson that the attached Elevation Plan marked Annex ‘A’ be finally adopted by the Department of Public Works and Highways (DPWH) with regards to the Western Urdaneta Bypass Road”;

WHEREAS, the current August Body is now calling on DPWH Secretary Mark Villar to continue the Bypass Road project as is or according to its original plan and design, keeping in mind the earnest efforts of Hon. Amado T. Espino Jr., Representative of the 5th District of Pangasinan, to prevent the reversion of funds to the national coffers;

WHEREFORE, in view of the foregoing, on motion of Coun. Florencio B. Aduca, duly seconded unanimously, it was:

RESOLVED, by the 7th Sangguniang Panlungsod of Urdaneta, in session assembled, to call on Secretary Mark Villar of the Department of Public Works and Highways (DPWH) to continue the seven-kilometer (7km) Western Urdaneta Bypass Road according to its original plan and design.

RESOLVED FURTHER, to cause copies of this resolution to be forwarded to Secretary Mark Villar of the Department of Public Works and Highways (DPWH), Bonifacio Drive, Port Area, Manila, for his proper information and appropriate action.
