**COMMENDING RET. P/DEP. DIR. GEN. ISIDRO S. LAPENA, A NATIVE SON OF URDANETA, FOR BEING APPOINTED AS DIRECTOR-GENERAL OF THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) BY PRESIDENT RODRIGO R. DUTERTE**

**WHEREAS**, President Rodrigo R. Duterte, has appointed Ret. P/Dep. Dir. Gen. Isidro S. Lapena, former Deputy Chief of the Philippine National Police (PNP), as Director-General of the Philippine Drug Enforcement Agency (PDEA), a position of great trust and responsibility;

**WHEREAS**, President Duterte’s appointment of Gen. Lapena as PDEA Chief underscores the perilous state of the illegal drugs problem, a job fraught with grave responsibilities and demands a man of character and integrity to take charge of the new administration’s top concern;

**WHEREAS**, Gen. Lapena, a native son of Urdaneta, amply fills this need for an anti-drug czar and he has vowed to turn his home city into a pilot area for drug enforcement in the country;
