**RESOLUTION NO. 9**

**- Series of 2016-2019 -**

**AMENDING RESOLUTION NO. 329, S. 2016, OF THE 6<sup>TH</sup> SANGGUNIANG PANLUNGSOD STATING THAT AN ADDITIONAL SEVEN (7) TRICYCLE FRANCHISES BE AWARDED TO EVERY BARANGAY, BY AUTHORIZING THE CITY MAYOR TO AWARD UNLIMITED FRANCHISES FOR THE OPERATION OF MOTORIZED TRICYCLES FOR HIRE IN THE CITY OF URDANETA UNTIL SUCH TIME THAT THE SAME MAY BE REVOKED BY THIS AUGUST BODY**

**WHEREAS**, Resolution No. 329, passed and approved by the previous Sangguniang Panlungsod on June 13, 2016, calls for an additional seven (7) tricycle franchises for every barangay;

**WHEREAS**, said Resolution No. 329 does not truly uplift the lives of our constituents as the awarding of limited franchises does not fulfill their wishes, or serve their interests, as intended by the previous Sanggunian;

**WHEREAS**, granting the City Mayor a blanket authority to issue unlimited tricycle franchises to our constituents serves the purpose of uplifting their lives;

**WHEREFORE**, in view of the foregoing, on joint motion of Councilors Jimmy D. Parayno, Antonino P. Perez, and Herodotus F. Sumera, duly seconded unanimously, it was:

**RESOLVED**, by the 7<sup>th</sup> Sangguniang Panlungsod of Urdaneta, in session assembled, to amend Resolution No. 329, s. 2016, of the 6<sup>th</sup> Sangguniang Panlungsod stating that an additional seven (7) tricycle franchises be awarded to every barangay, by authorizing the City Mayor to award unlimited franchises for the operation of motorized tricycles for hire in the City of Urdaneta until such time that the same may be revoked by this August Body.

**RESOLVED FURTHER**, to cause copies of this resolution to be furnished to the City Mayor, Hon. Amadeo Gregorio E. Perez IV, for his proper information and appropriate action.
